## New Recycling Laws

Recycling of disposable materials has become increasingly more essential in recent years as population size and garbage creation has grown to record levels. The sheer volume of household waste has become both an environmental and economic challenge for individual municipalities as well as Westchester County.

Recently the Astorino Administration and the Committee on Environment and Energy announced a significant equipment upgrade to the County's Materials and Recovery Facility (MRF) that will enable the range of recyclable material to expand. Previously, the County's facility could only accept plastics labeled #1 or #2. With the new facility upgrade, the County facility will be able to accept plastics from #3 through #7. This expands the County recycling ability from water and soda bottles and detergent or milk containers to items such as yogurt cups, food containers and mixed plastics.

This change in recycling capability required a change in the Westchester County Source Separation Law, which dictates the material required to be recycled county wide. The Environment and Energy Committee has worked

closely with the Astorino Administration through the Environmental Facilities and Law Departments to amend the existing law to include the new list of materials that can and must be recycled.

As a member of the Environment and Energy Committee I supported the expansion of recycling to include plastics up to #7. This is a huge advancement for Westchester County because it will create not only significant environmental impacts but the costs of refuse disposal by individual municipalities throughout Westchester will be reduced at a time when operating costs must be reduced across the board.

It is important to point out that the revenues for recycled plastics will increase for the County. The value of higher numbered plastics has increased due to the market demand for these materials. The combination of reduced disposal costs with expanded revenues comes at a time when all operational costs are being reviewed and evaluated to reduce the cost of County government.

The expanded recycling law went into effect for Westchester residents on June 1, 2011.

## District 1 Communities' Tax Reduction Will Exceed the -2.2% County Levy Adopted for 2011

Although overall county spending is still too high and the level of some projected revenues is no more than wishful thinking, the Westchester County's overall tax rate for 2011 will be cut for the first time in decades! The overall -2.2% tax reduction is the result of a year's worth of pressure by County Executive Astorino and the insistence by Republican legislators to change the way county government operates. After 12 years of unrelenting increases in spending and ever expanding programs, it's long past the time to change the attitudes, costs and how county government does its job. We still have a long way to go. Due to inconsistent NY State equalization rates and varying assessment throughout the county, the county tax rate is different for each community. Although a few will see an increase in their tax rate, most will experience a reduction. The municipalities I represent in District 1 will all see a significant reduction in their county tax bills this year. According to the


Westchester County Tax Commission, the City of Peekskill will have a -5.91% tax reduction, the Town of Cortlandt -2.26% and Yorktown -2.98%. There is still much to be done. Spending is still too high. Unfortunately the supermajority restored \$38 million in spending to the 2011 budget by overriding County Executive Astorino's vetoes. Lawsuits have been initiated by the supermajority to stop the county executive from streamlining the workforce and eliminating expensive, unnecessary contracts. Rest assured, I will continue to work with County Executive Astorino to further the right sizing of county government and bring relief to the hard working families of Westchester. We have done much in just one year's time. Image where we will be as we continue to push for policies that make sense for the residents of Westchester. You can count on me to do just that.

## Redistricting Plan Adopted

County Executive Robert Astorino vetoed the redistricting plan that was approved by the Board of Legislators, which then voted along party lines to override his veto. The 12 member supermajority on the board voted in favor of the plan, the 5 GOP legislators voted against it. I had repeatedly called on the county executive to veto this deeply flawed plan being forced on the citizens of Westchester. I am grateful that Rob Astorino supported my call to reject this partisan redistricting plan. Unfortunately, the plan is now county law that Westchester citizens must live with for the next decade.

In contradiction to claims that the redistricting process would be fair and transparent, a plan was adopted that ignored my concerns and requests as well as those of some of my colleagues and any meaningful input from the public. It is unacceptable to me that the City of Peekskill has been divided between two legislative districts. It had never been done before because there was no legitimate reason for it to happen. It is bad policy and bad government.

Even the nonpartisan League of Women Voters of Westchester had distanced themselves from the plan saying, "The process has been extremely messy and aspects of it have been questionable." The LWV went on to say, "We understand the committee is working to meet a June deadline. We do not believe however that this excuses the general sloppiness, if not partisan political nature of the proceedings."

I have to accept the fact that when a 12-5 supermajority is in charge of redrawing the voting lines for the entire county, they will take some advantage of that opportunity. What I won't accept are the claims that this was a fair and transparent process that addressed the concerns of all legislators. The fact is the citizens of Westchester were ignored, misinformed and ultimately cut out of the process.

Even with these changes, I look forward to meeting my new constituents in District 1 and, rest assured, I will continue to put interests of all residents of Peekskill, Cortlandt and Yorktown before those of county government.

## Charter Revision Commission Appointment

I am pleased to announce that I appointed John Mattis to The Charter Revision Commission. John has been a resident of the Town of Cortlandt for 38 years. He holds an M.B.A. in Finance from Fordham University and works as a financial advisor. John has been a civic leader for years, serving in such positions as; Chairman, Town of Cortlandt Zoning Board of Appeals and the Westchester County Compensation Advisory Board. The Charter Revision Commission will be composed of a total of 23 volunteer members. Each of the 17 County Legislators have individually appointed 1 member to the Commission. Westchester County Executive Rob Astorino appointed 6 members to the Commission. The panel is charged with amending or revising the existing charter, holding public hearings throughout the county to solicit public input, review and recommend changes and to issue a report outlining its findings.
